**8-17 ALBERTA ELECTORAL BOUNDARIES COMMISSION – BOUNDARY REVIEW** The County Manager reported on the letter received from Alberta Electoral Boundaries Commission dated December 12, 2016 advising that 2017 will be spent reviewing the boundaries and names of the 87 electoral constituencies in the Province.

In this review, the Electoral Boundaries Commission is looking forward to hearing from interested Albertans who wish to contribute to the redrawing of Alberta’s constituency map and is encouraging municipalities to participate in the public consultation by preparing a written submission on how best to update the constituency map of Alberta. An interim report will be submitted to the Speaker of the Legislative Assembly before May 31, 2017 and a final report will be submitted by October 31, 2017.
