- RANFURLY LANDFILL – PROPOSED RECLAMATION PROJECT UPDATE** The County Manager presented an update on the proposed Ranfurly Landfill Reclamation Project. A site inspection was completed on June 29, 2016 with Alberta Environment and Parks, Associated Engineering and the Superintendent of Public Works in attendance. Alberta Environment and Parks Contamination Hydrologist advised in an e-mail dated July 14, 2016 that he had no objections to the proposed plan to finalize the closure of the existing landfill cell with the addition of the topsoil material.
