**CANADIAN COYOTE ENERGY LTD.** The County Manager reported the following information regarding the Canadian Coyote Energy Ltd. Tax Arrears Seizure:

In consultation with Allan Farmer of Reynolds Mirth Richards & Farmer (RMRF) LLP for collection of tax arrears, the County of Minburn needed to seize quickly the assets of Canadian Coyote Energy Ltd. as they are going into receivership and have many creditors.

The County of Minburn issued distress warrants as per Section 440 of the *Municipal Government Act (MGA)* on July 25, 2016 and seized Canadian Coyote Energy Ltd. assets to recover \$152,855.04 in tax arrears. No objection to the seizure was received and no payment was made by Canadian Coyote Energy Ltd. for the taxes.

Total estimated cost of the tax arrears seizure to-date is \$9,503.90 which includes invoices paid in the amount of \$4,503.90 and estimated staff time in the amount of \$5,000.00.

**138-16 TAX ARREARS EQUIPMENT SEIZURE AND SALE** Councillor Rattray moved the County of Minburn proceed as per Sections 437 through 452 of the *Municipal Government Act (MGA)* regarding the seizure and sale of Canadian Coyote Energy Ltd. equipment to recover tax arrears owing in the amount of \$152,855.04.

**REVIEW OF VALUE OF EQUIPMENT SEIZED** County Administration reviewed the value of all equipment seized in consultation with County of Minburn Assessor Ray Crews of Municipal Assessment Services Group (MASG).

**139-16 EQUIPMENT SEIZED – RESERVE BID** Deputy Reeve Ogradnick moved the County of Minburn at the Public Auction place a reserve bid on all Canadian Coyote Energy Ltd. seized equipment for the total amount of \$128,370.00 as per the list dated September 2, 2016.

Councillor Melenka moved the County of Minburn accept the quote and work plan received from KBD Picker Services in the amount of \$39,515.00 plus G.S.T. for dismantling, loading and hauling to Vegreville County Public Works shop yard from all the sites as indicated in the Seized Equipment Inventory list dated September 2, 2016 and dispose of any waste materials. Landowners are to be consulted prior to seized equipment being moved and the contractor is to ensure no crops are damaged or fence removed.
