hereby confirm that I wish to have the County of Minburn (the "County") plow the driveway of the Lands. I understand that in relation to the Lands, there is a risk that in providing that service, the County or its agents or employees could cause some injury or damage to the Lands or any personal property or improvements on the Lands, and I accept that risk in requesting the County provide this service.

Accordingly, on behalf of myself, my heirs, executors, administrators, and assigns, and in consideration as hereinafter set out and other good and valuable consideration (the receipt and sufficiency of which consideration is hereby acknowledged) I agree as follows:

- The Owner grants to the County the right to enter in, on or upon and use the Lands ("Right-of-Entry") by its employees, contractors, implements, machinery, and other equipment as may be necessary for the purpose of clearing snow, plowing the driveway on my Lands, and any related work (the "Work") from the date of this Agreement until I revoke such agreement in writing to the County.
- 2. The Owner agrees that such Right-of-Entry is not a representation, commitment or guarantee by the County of any particular level of service or that the Work will continue to be performed by the County on any given schedule, or at all.
- 3. In consideration of the Work, the Owner agrees as follows:
  - a) The County shall not be liable, directly, or indirectly, for any personal injuries that may be suffered or sustained by any person who may be on the Lands or for any loss of, or damage to, or injury to property belonging to the Owner or any other person, including any injury, loss or damage caused by negligence of the County, and:
  - b) The Owner shall at all times indemnify and save harmless the County, its officers, elected officials, employees and agents, from and against any and all liabilities, claims, demands, losses, costs, charges, expenses (including without limiting the generality of the foregoing, all legal fees and disbursements on a solicitor and own client basis, and any amount paid to settle any actions or satisfy any judgements), actions and other proceedings in respect of anything arising from the Work or the County's access to or use of the Lands under this Agreement.

4.	The Owner agrees and understands that the County will clear snow to only one
	driveway per residence, up to the residence. The County will not clear to
	outbuildings, grain bins, or feed stacks, and farmyards. The County reserves
	the right to deny driveway or access clearing requests if the Director of
	Operations or their designate deems the driveway or access unsafe for County
	equipment.

And the Owner's agreement and obligations under this provision shall survive the expiry or termination of this Agreement, howsoever it occurs.
